

Please read the Terms of Service and Release of Liability provided below.

## **INTENT TO REGISTER**

By signing and submitting this registration form the traveler indicates that he/she is intentionally registering for the **2303 Midway Church** and that by submitting this form and a financial deposit/payment, the traveler is entering into a binding contract that requires specific financial payments at specified times.

This registration is not official until Discipleship Travel LLC receives the appropriate financial deposit/payment whether that be via check, credit/debit card, or ACH.

Any delay in receipt of the traveler's payment by Discipleship Travel LLC may allow others to register ahead of the traveler named herein, possibly moving the named traveler to the wait-list. If the traveler chooses not to be wait-listed he/she may request a refund without penalty.

## **PRIVACY POLICY**

In order for Discipleship Travel LLC to make travel arrangements for the **2303 Midway Church**, the traveler is required to provide the necessary personal data.

## **PAYMENT POLICY AND PRICING**

Discipleship Travel LLC publishes the cash/check discount price for tours. As a convenience to traveler's, Discipleship Travel LLC offers the option to pay fees by credit/debit card or ACH (eCheck) via the company website. By selecting credit/debit card or ACH payment, the traveler agrees to pay the additional fees associated with this service. A credit/debit card payment requires an additional fee of 3% of the payment amount + \$0.30 transaction fee. An ACH payment requires an additional fee of 1% of the payment amount + \$0.26 transaction fee. The traveler agrees to check the box on the payment portal that includes the additional fee at the time of payment or the traveler will be billed by Discipleship Travel LLC.

All traveler fees must be paid prior to travel.

The full-package price for this group is **\$4,400**. The child price for this group is **\$4,050**. The single supplement fee is **\$1,000**.

The full-package originates and ends in Detroit (**ATL**). All costs related to getting to/from the airport or parking fees while on the tour are the sole responsibility of the participant, and are not included in the tour price.

The Ground-Only package includes everything the full-package includes *except airfare*. Ground-Only participants must provide their own transportation, and it must be coordinated with the group's Tel Aviv arrival and departure.

INCLUDED IN TOUR PRICE: coach airfare◇, double-occupancy† accommodations in superior to deluxe hotels, entry fees, guides, drivers, breakfast and dinner^ at the hotels, climate-controlled buses, portage, taxes and tips (hotel staff, drivers, and guides). NOTE: No refunds will be offered for any unused elements of the package.

† A single room requires a supplement fee. (See pricing above.) Discipleship Travel LLC is not responsible to provide a roommate. Each participant is responsible to provide their own roommates.

^ All meals are prepared in industry regulated kitchens that are licensed by the appropriate health boards, but Discipleship Travel LLC neither guarantees nor represents that in-flight and/or hotel meals will meet specific allergy or dietary restrictions of any participant.

NOT INCLUDED IN TOUR COST: Lunches, *a la carte* beverages at buffets (e.g., soft drinks and alcohol), daily water or snacks, souvenirs or personal expenses, any expenses resulting from illness or accident, passport costs, or any other expenses not specifically mentioned as *included* in the tour brochure or web page, or any other services not specifically mentioned as *included* in the tour brochure or web page.

PAYMENT SCHEDULE: A deposit of \$300 must be submitted by **November 15, 2022**. Fifty percent (50%) of the tour price must be paid by **March 7, 2023**, 130 days prior to departure. The final balance must be paid by **April 26, 2023**, 75 days prior to departure. Late payments will incur a \$25 non-refundable late fee and/or may cause forfeiture of registration.

LIMITED SPACE: Space is limited for this tour. Additional space may be available at an upcharge.

MINIMUM PARTICIPANTS: The minimum number of paying participants for this tour is twenty (20). In the case that twenty (20) paying participants fail to register by 135 days prior to departure, the group request will be canceled by Discipleship Travel LLC and all payments, less a \$100/per person handling fee, will be returned. If the group drops below twenty (20) paid participants at any time less than 135 days prior to departure a supplemental fee will be required. The amount of the supplement will be determined by the number of paying participants remaining. If the number of participants using the group air service, drops below 10, the group air reservation will be converted to individual tickets and priced accordingly by the airline. If the group fails to be viable or incurs additional fees due to reduced numbers of participants, Discipleship Travel LLC is not responsible for, nor will Discipleship Travel LLC reimburse any expenses incurred by participants in preparation for the tour.

## ITINERARY CHANGES

The related itinerary is subject to change according to local conditions, which may include, among other things, weather, security and crowd considerations. If an itinerary change

necessitates extra overnights, each participant will be responsible for any additional costs.

## **PASSPORTS**

All participants must have a passport that is valid for at least 6 months beyond their return date. Any participant that intends to travel on a non-USA passport, is solely responsible for knowing and meeting the entry requirements for their destination country. Each participant is solely responsible to obtain and maintain a valid passport. Discipleship Travel LLC is not responsible to secure a passport for participants, nor for verifying the validity of currently held passports.

By registering for this tour, participants give Discipleship Travel LLC permission to use and publish photographs in which they may be included for the use of promotion, print, editorial, advertising or other related purposes without financial compensation. Additionally, by registering for this tour, participants specifically release Discipleship Travel LLC from all claims and liability relating to said photographs.

## **BAGGAGE ALLOWANCE**

Due to airline contracts, bus size, and included portorage, participants are allowed one checked bag, not to exceed 62 inches (length plus width plus depth) and 50 lbs. Participants may also bring one carry-on item and one personal item. Participants should consult the airline's international baggage regulations as restrictions frequently vary by airline and may change without notice.

## **CANCELATION REFUND POLICY**

The following cancellation/refund policy applies to **2303 Midway Church**:

Cancellations up to 131 days prior to group departure will receive a full refund less a \$100 processing fee.

Any cancellation between 130-91 days prior to group departure will receive a full refund less a \$500 penalty plus any airline penalties\*\*.

Any cancellation between 90-75 days prior to group departure will receive a full refund less a \$1500 penalty plus any airline penalties\*\*.

Any cancellation less than 75 days prior to group departure will receive no refund.

\*\*Airline penalties refers to any cancellation fee(s) imposed by the airline and/or any fund not recovered from the airline. According to the specific airline contract, cancellations may result in

a credit or travel voucher from the airline, depending on the date of cancellation. Travel credits/vouchers can be used in the future according to the conditions established by the airline.

Tours are not transferable.

## **COVID-19 PROTOCOLS**

The registered traveler is responsible to comply with all Covid-19 protocols/regulations published by the airlines and any relevant government authorities regardless of the timing of said protocols. Covid-19 protocols are fluid, regularly changing according to current conditions.
